




Forest Products Exports 2005 (CAN\$ Billions)




An Immense Forested A Landscape (Millions of hectares)


Today's forest as a % of Original Forest Area

Virtually Zero Deforestation

Countries with high net change in forest area, 2000-2005

Over 90% of natural forests lost in the tropics are converted to non-forest uses, primarily agriculture


>0.5% decrease per year



Federal Government Agencies and Acts

Legislation created by the Canadian Federal Government impacts forest management in Provinces

- ✓ *Fisheries Act* Department of Fisheries and Oceans
- Canadian Environmental Assessment Act Canadian Environmental Assessment Agency
- ✓ Pest Control Products Act Health Canada
- ✓ *Navigable Waters Protection Act* Transport Canada
- ✓ Canadian Forestry Services
- ✓ Species at Risk Act Environment Canada



- The Canadian constitution delegates jurisdiction over natural resources to provinces
- Provincial legislation dictates:
 - Tenure arrangements
 - Environmental standards that apply to Crown lands

Provincial Acts – BC Example

Provincial legislation dictates tenure arrangements and environmental standards on public (Crown) land

- ✓ Ministry of Forests and Range Act
- ✓ Forest Act
- ✓ Forest and Range Practices Act
- ✓ Land Act
- ✓ Range Act
- ✓ Water Act
- ✓ Wildfire Act

BC Forest Act

Provides the <u>authority for the allocation and</u> <u>administration</u> of forest resources, primarily timber.

- ✓ Regulates <u>rate of cutting</u>
- ✓ Specifies forms and <u>content of agreements</u>
- ✓ Provides for basic tenure administration
- ✓ Basics for aspects of <u>compliance and enforcement</u>



BC Forest and Range Practices Act

Provides for the <u>regulation of operational planning and</u> <u>practices</u>.

- ✓ Establishes <u>stewardship standards</u> for forest and range practices
- Ensures that the legislated requirements for sustainable forest practices are followed
- Meets the requirements for higher level plan objectives established through strategic planning
- ✓ Carry out <u>compliance and enforcement</u> activities to ensure stewardship standards are met

What are Tenures?

Mechanism by which government transfers specific rights to use Crown forest resources through:

- Iegislation Forest Act
- ➤ regulation
- ➤ contracts
- ➢ policy

... and defines the licensee's obligations.

Tenure Administration

- 1. Administer licence
- 2. Approve Forest Stewardship Plan
- 3. Issue road permit
- 4. Issue cutting permit
- 5. Monitor Performance
- 6. Collect Revenue



Forest Planning and Regulation

- Long term licenses
- 20-25 year forest management plans
- Rolling 5 year development plans and site specific annual operational plans
- Forest management plans subject to public review prior to approval
- All harvested areas must, by law, be regenerated

How do Canadian Regulations Compare?

- Protected areas
- Species at Risk
- Certification
- Riparian Protection
- Clearcutting
- Road Construction
- Reforestation
- Allowable harvest

This Report demonstrates that the stringency of Canadian forestry regulations compare with the most stringent of policies elsewhere in the world. In most cases, Canadian policy and regulation is non-discretionary and involves specific requirements. Results of this study indicate that Canada is well positioned to begin much needed global efforts to address important problems concerning the world's forests

Compliance & Enforcement

"Independent yet Integrated"

C&E is integrated into government activity, but maintains its ability to act independently.


- Independent: acts on legal authority, unbiased and independent of irrelevant considerations
- **Integrated:** operates efficiently and communicates effectively with other program areas within the Ministry

Compliance & Enforcement

- Enforce environmental standards under legislation;
- Conduct investigations where evidence of contravention;
- Enforce regulations to minimize fire, pests and unauthorized activities;
- Combat <u>forest crimes</u> that impact provincial revenues (theft, arson, mischief);
- Enforce <u>revenue policies</u>.

Number of Inspections by Inspection Type







SFM Certification in Canada 1999-2007 (millions of hectares)







Traceability (2006)




- All harvested forests are promptly regenerated and do not contribute to deforestation


